(Backlogs) , BE (Bridge Course) I & II semester and I Year (Backlogs) and Improvement** examinations will be conducted in the month of **November 2018**. ### **SPECIAL INSTRUCTIONS TO THE PRINCIPALS**

- The College login will be closed after the last date. (26-10-2018)
- In case the fee is not remitted to the O.U. A/c. **OR** if online EAFs are not submitted on or before due date even if fees remitted into fund account within due date. **(Late submission of forms by the College beyond the date prescribed attracts penalty @ Rs.1500/- per day and to be borne by the college)**
- Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.
- The Principals are requested to transfer Consolidated exam fee amount into The Registrar, Examination fee fund, O.U., A/c No. 52198262033 **(SBI, O.U. Branch, IFSC Code "SBIN0020071")**, O.U. through NEFT/RTGS only.

**Third Semester Fresh Admissions(Lateral Entry):-** The examination application forms of **III semester** students admitted during the academic year 2018-2019 are to be submitted **online** through college login. Also, hardcopy of the same may be downloaded and submitted to the examination branch duly signed by the student and the Principal concerned along with photocopy of qualifying examination i.e. Polytechnic (ECET-2018) and duly approved by the Convener, ECET – 2018/ Chairman, TSSCHE, Hyderabad/ Directorate of Admissions , O.U.

### **Conditions:-**

1. *The colleges have to get the clearance letter from (a) the Director, Directorate of Academic Audit, O.U., (b) Convener TS ECET and (c) No Dues from the Deputy Registrar, Academic Section, O.U. and submit the examination forms through college login. Clearance certificate from Nodal Officer, Statistical Cell, OU.*
2. *As a part of the Core Banking System, all the students are hereby instructed to deposit the Examination Fee into their respective college accounts only for onward transmission to the University by the college.*

3. *The Principal of Engineering Colleges are requested to collect the examination expenses from each of the **III semester** students @ Rs.300/- per head and remit the consolidated amount to the Registrar, OU together with examination fee and application form in terms of OU Circular No. 3872/D/37/93/Acad., dt.15-12-1993.*
4. *All the Principals are requested to verify the eligibility of the students thoroughly and forward the same to this office for the issue of Hall Ticket. If failed to verify the eligibility of the candidates, the principal will be held responsible for the issue of hall ticket to the non-eligible candidates.*
5. *The students who have passed Diploma from other than Board of Technical Education, T.S. have to pay Rs. 125=00 in addition to examination fee towards Migration fee. The students should submit Migration certificate in original along with the examination form and fee at their respective college principals on or before **26/10/2018** for onward transmission to the Controller of Examinations for issue of hall tickets.*
6. ***Not to collect the Exam fee from Visually/Physically Challenged and Hearing Impairment students as per O.U. Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008. A Xerox copy of medical Certificate confirming their status. (Minimum percentage of disability must be of 40% attached to the application forms.) Visually/Physically Challenged and Hearing Impairment students applications forms should be submitted separately along with separate Nominal Roll.***
7. *Any discrepancies with regards to the Candidate's data such as Internal marks, Practical etc. should be brought to the notice of concerned officials of Examination Branch and obtain the acknowledgement before declaration of the results. After declaration of the results, queries will not be entertained.*
8. *In respect of the candidates who have completed course requirement having appeared for IV//II semester and completed double the duration of course but did not cross **(10)** years for **Regular** and **(8)** years for **Lateral Entry** students from the date of admission have to pay an additional amount of **Rs.1000/-** per subject, semester-wise along with normal semester fee and submit N R in duplicate separately login.*
