- Members opined that, Plagiarism checking is to be introduced M.E/M.Tech student dissertation work. Members also felt that the possibility of bringing in the regulation with regard to research paper publication by students in International/National level conference /journals is very much needed.
- Documents retrieval is taking long time and steps to be initiated to reduce delay time to fetch the required documents (this point was noticed during the recent NBA visit in Feb 2017).
- Some of the members present felt that, COs are not measurable with respect to end semester question paper, assignment and Quiz. How to conduct question paper auditing.

- 6. Admin Officer Sri. Goverdhan Rao suggested to facilitate to have a single window system for students to issue a certificates like bonafide, etc...
