# 2. Review of the Action Taken Report on the resolutions adopted in the 27<sup>th</sup>IQAC meeting held on 07.10.2023:

The Action Taken report on the resolutions made in the 27<sup>th</sup> meeting of IQAC is presented by Prof. A.S. Sai Prasad, Coordinator, IQAC and the ATR is reviewed by the members.

6.	Introducing B.E. (Minor) Degree in Computer Science for the students of Civil, Mech, EEE& ECE admitted w.e.f. 2022-2023 academic year onwards.	Principal informed members that college has decided to introduce BE (Minor) Degree in Computer Science Engineering for Civil, Mech, EEE& ECE students admitted from the academic year 2022-2023 onwards. Accordingly the college Academic Counsel and BOG have approved the proposal and regulations.			

After review, the IQAC has approved the action taken report.

# 3. Fixing of a date for conducting Energy Audit, Green Audit and Environment Quality Audit:

The HoD-EEE has explained that the inspection process is going on for Energy Audit and Green Audit and application has been submitted to Divisional Engineer (Operations), TSSPDCL, Hyderabad for CEIG approval of the connected load in the College and also for power quality audit to Divisional Engineer (MRT). The above inspection will be completed by the end of March, 2024. In this connection, the CEO has suggested to identify the ways to conserve the energy. Ms. Ch. Phani Madhuri, Member, has suggested to introduce ISO based Audits. The Principal has suggested to follow the standard norms as prescribed by the certified auditors during the audit process. The HoD-Chemistry will take-up Environment Quality Audit in the campus and complete by 31st March, 2024.

#### 4. Training session on LATEX to the members of the faculty:

It is resolved to conduct a training session on Latex to the faculty members to train them on "Basics of Latex Typesetting System" and "How to prepare journal articles". The HoD-CSE is advised to plan for conducting a training session in March/April 2024. The CEO has suggested to identify an Expert Trainer on "LATEX".

# 5. Review of the Women Welfare activities and gender sensitization activities to be conducted by the Internal Complaints Committee:

It is resolved to conduct the following additional programmes to improve the social and economic awareness among females and to infuse the strength of womanhood in them:

- > Enlighten the women students about their legal rights and to strive towards the empowerment of the women through the promotion of gender amity and programmes concerning women welfare.
- Training by a banking professional on various topics related to money transactions and schemes.
- > Training to develop martial arts skills in students and faculties.
- > A workshop by Lady Police Officers, giving awareness about social issues and women safety.
- Workshop on Awareness about mental, sexual harassment and grooming of the same.
- Stress management. (Off Session)

#### 6. <u>Enrolment into National Academic Depository System:</u>

It is resolved to register the institute for National Academic Depository (NAD) to digitally, securely and quickly issue of online Academic Awards to the students directly in their online NAD account, in addition to the data pertaining to the Affiliated Colleges uploaded by the Osmania University. The Controller of Examinations, VCE, is requested to initiate the registration process at the earliest as well as uploading the students' data into NDML (National Database Management Limited) appointed by the MHRD.

### 7. Review of the submission of AQAR 2022 -2023:

The members of IQAC have reviewed the details (Data as well as documents) pertaining to AQAR 2022-2023 and approved for uploading the same on the NAAC Portal on or before 29.02.2024.

#### 8. Other items:

- The CEO advised to review the targets in respect of all NAAC Criteria once in a fortnight (i.e., on 2<sup>nd</sup>& 4<sup>th</sup> Saturdays) henceforth to ensure the seamless conduct of all activities.
- 8.2 It is noted that NAAC Accreditation henceforth will be on the outcome based but not on the input basis. Hence, it is decided to prepare 1) Learnings from Audits, 2) Learnings from Trainings / Workshops, 3) Learnings from FDPs, 4) Outcome from changed methodology / Regulations of Teaching-learning(no.of graduates without the history of backlogs correlation between CGPA and Placements
- 8.3 Dr. P. Mastanaiah, Scientist 'F', DRDL, has suggested to prepare a list of Projects/expertise developed by the students and faculty and showcase them to industries/R & D organizations.
- 8.4 Dr. Ramprasad, Associate Professor, Department of Mathematics, has explained that the department is proposing to offer B.E Minors in Mathematics.
  - The detailed Scheme of Instruction & Examination and its Regulations will be presented in the BoS and Academic Council for necessary approvals.
- 8.5 The Principal has informed that college has applied for extension of NBA for UG-Civil, ECE, EEE, Mech & CSE programs and the Expert Team visit is scheduled on 2<sup>nd</sup> March, 2024 to review the compliance report submitted.
